Travel and accommodations for one representative: FNFA will cover costs associated with travel for your representative to attend the AGM and its events as follows: economy airfare, mileage if you are driving from nearby, accommodations for a maximum of 4 nights at Casino Rama Resort, meals and transportation.

Additional representative: FNFA will also cover costs for one additional representative to participate in the AGM and its events, however, we will not cover costs for travel and accommodations for this individual.

Travel: You must make your own travel arrangements and FNFA will reimburse you. We will confirm guidelines and provide an expense claim form to submit with your receipts.

Hotel: We will make your hotel reservation.

AGM Board Elections: In accordance with our BYLAW and the *First Nations Fiscal Management Act*, the FNFA shall hold elections for a Chairperson, Deputy Chairperson and Directors which will be held, and members duly elected for a one-year term.

It is important that the directors including the Chairperson and Deputy Chairperson are geographically represented from FNFA's members. Both rating agencies that FNFA receives a rating from, have indicated the importance of the geographical and gender diversity of the membership. FNFA's objective for the election of Directors is to be on-side with the rating agencies and ensure the representation meets the rating agencies criteria.

During the course of the year if the Chairperson, Deputy Chairperson and Director no longer hold office as a Chief or Councillor, that individual also ceases to be a Director of the FNFA. If your First Nation will be holding an election during the year, please keep this in mind if you are considering being elected to the FNFA board.
